What is the overall <b>deductible</b> ?	\$3,250 individual / \$6,500 family aggregate. <u>Co-insurance</u> and <u>co-payments</u> do not apply to the <u>deductible</u> . This benefit combines your prescription drug and medical <u>deductibles</u> .	Generally, you must pay all of the costs from providers up to the <u>deductible</u> amount each <u>plan</u> year before this <u>plan</u> begins to pay. If you have other family members on the policy, the overall family <u>deductible</u> must be met before the <u>plan</u> begins to pay. Your <u>plan</u> year: 01/01/2024 through 12/31/2024.
Are there services covered before you meet your <u>deductible</u> ?	Yes, <u>preventive care</u> , dental class I, the first four primary care, mental health and substance abuse office visits (including routine lab services) combined up to a total of twelve visits per family, wellness drugs, pediatric vision	This <u>plan</u> covers some items and services even if you haven't yet met the <u>deductible</u> amount.
