What is the overall deductible?	\$4,725 individual <u>plan</u> / \$9,450 family aggregate. <u>Co-insurance</u> and <u>co-payments</u> do not apply to the <u>deductible</u> . This benefit combines your prescription drug and medical <u>deductibles</u> . Are there services covered before you meet your <u>deductible</u> ?
